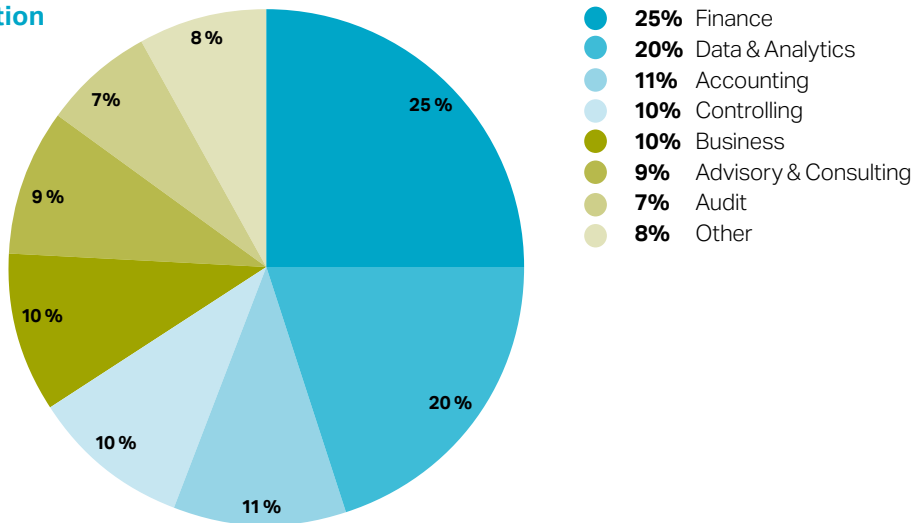

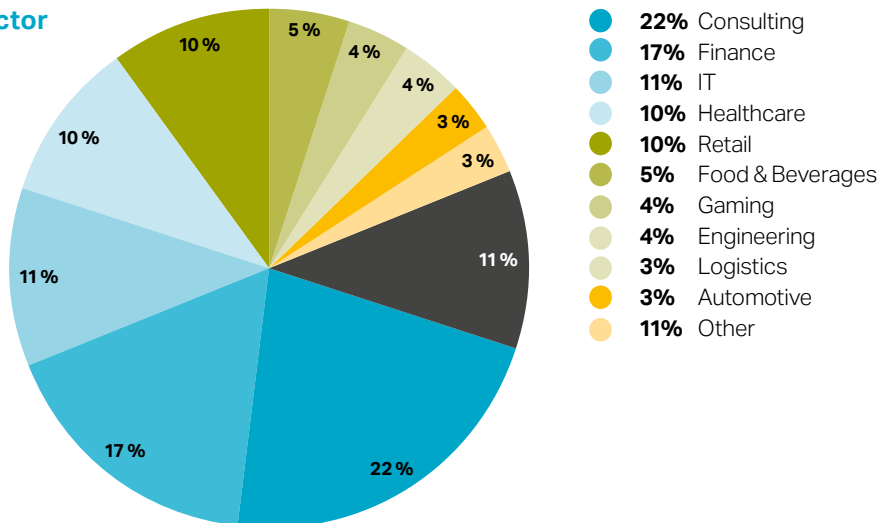

Admission requirements

Dutch students

- ✓ For our four-year programme, you'll need a Dutch senior general secondary education (HAVO), pre-university education (VWO), or vocational education (MBO-4) diploma.
- ✓ For our three-year programme, you'll need a VWO diploma, a propaedeutic certificate from a Dutch research university, or a bachelor's degree.

International students

English language entry requirements for four-year bachelor's programme

- ✓ IELTS: minimum score of 6.0 overall
- ✓ TOEFL internet-based test: minimum score of 80
- ✓ TOEIC: minimum scores of 670 (listening and reading) and 290 (speaking and writing)
- ✓ Cambridge English: minimum score of 169 (and grade A, B or C)

English language entry requirements for three-year bachelor's programme

- ✓ IELTS: minimum of 6.0 overall and 6.0 for each sub-score
- ✓ TOEFL internet-based test: minimum score of 80 and 20 for each sub-score
- ✓ TOEIC: minimum scores of 670 (listening and reading) and 290 (speaking and writing)
- ✓ Cambridge English: minimum score of 169 (and grade A, B, or C) and 169 for each sub-score
