## Explanatary notes on the payment of tuition fees 2023-2024

### Filling out this form

Please use the digital payment authorisation in Studielink to pay your tuition fees. The form "One-off power of attorney for the payment of tuition fees 2023-2024" may only be used to change your payment details after you've arranged your payment in Studielink, or if you experience problems using the digital payment autorisation.

Please fill out your personal details and your bank account details. Indicate the tuition fee that applies to you (see Tuition fee amounts). If you do not check the amount, The Hague University of Applied Sciences will determine the amount due, based on the data in our files. Furthermore, we ask you to indicate if the tuition fees should be debited in 1 or 9 instalments. If you do not make a choice here, we will debit the tuition fees in 9 instalments (including an administrative fee).

The form must be signed by the person who pays the tuition fees (box 1) and by you as a student (box 2). If you pay the tuition fees yourself, you must sign in both boxes yourself. If you are underage, a parent or guardian must sign in box 3.

#### **Tuition fee amounts**

The statutory tuition fee amounts to € 2,314. The institutional tuition fee amounts to € 9,045. The halved statutory tuition fee amounts to € 1,157. At www.thehagueuniversity.com/tuitionfees, you can find the tuition fee amount that applies to you. Please check the tuition fee amount that applies to you on the front side of this form.

If you are not an EU/EEA national and do you meet all the requirement for payment of the statutory fee of € 2,314? We will get in touch with you to let you know which additional documents or information we need.

- If it turns out that you do not meet the criteria for the statutory tuition fee (see our website), we will automatically debit the institutional tuition fee.
   We will send you a notification if this is the case.
- If it turns out that you do not meet all the conditions for the halved statutory tuition fees (see website) in the end, we will adjust your rate automatically to the statutory tuition fee. You will receive a message if this proves to be the case.

#### SEPA debit: Single Euro Payments Area

The Hague University of Applied Sciences will collect the tuition fees by SEPA (Single Euro Payments Area). A direct debit is possible if you have an IBAN account from one of the following countries: an EU member state, Norway, Iceland, Liechtenstein, Switzerland, Monaco, San Marino or the United Kingdom.

IBAN stands for International Bank Account Number. IBANs have a similar form in each country. In the Netherlands, the IBAN consist of 18 digits; elsewhere it can vary between 15 to 34 digits.

You can find your IBAN on your paper or digital bank statement or check your IBAN at your debit card.

#### **Instalment dates**

If you choose to have the tuition fees debited in 1 instalment, we will debit the tuition fees on 25 September 2023.

If you choose to have the tuition fees debited in 9 instalments, we will debit the instalments on the following dates:

25 September 2023, 25 October 2023, 27 November 2023, 22 December 2023, 25 January 2024, 26 February 2024, 25 March 2024, 25 April 2024 and 27 May 2024.

Please note: In case of payment in 9 instalments, a € 24 administrative fee will be debited along with the first instalment.
