2. Passed at least one of the following courses: Mathematics (Year 1) and/or Statistics (3) (Year 2).

2 **Graduation Project entry requirements:**

1. Internship Year 2 completed and at least 2100 study hours or 75 ECTS (internship included) of the main phase obtained.
2. Mandatory participation during Personal Development (3).

3 **Graduation requirement:**

Students must obtain 15 ECTS abroad either through an internship, student exchange programme or graduation project (thesis).

Exceptions:

Foreign students are already considered to be abroad.

Students from the Dutch territories (so outside of the Netherlands) are considered to be abroad.

Students from the Netherlands with a Dutch passport who graduated from high school abroad are in principle considered to be abroad.
